*Note: Registration of a Vehicle is only open to "members in good standing" as defined in the Miami Beach Association (MBA) Charter. It may be revoked at the sole discretion and decision of the MBA Board of Governors due to violations of the rules, terms and conditions stated below as well as the rules, regulations and ordinances of the MBA.*

### **Rules of Operation of Golf Carts and Mopeds on MBA Roads**

The Vehicle Owner or Operator agrees to comply with the following rules of operation:

- a. Vehicle Owner must be over 18 years of age
- b. Vehicle Operator must be a minimum of 16 years of age and hold a valid driver's license
- c. Operators must comply with all driving laws of the State of Connecticut and obey all posted MBA street, parking lot, speed limit and other traffic control signs
- d. Passengers are allowed on Vehicles only if proper seating is provided for the passenger(s) on the Vehicle
- e. No Vehicle parking is allowed on MBA streets. Parking is provided in designated areas in MBA Beach Parking Lot
- f. Operators agree to drive slowly through the parking lot; not cut through woods, lawns or private property or any area that is not intended for vehicle travel
- g. The Vehicle Owner agrees to be solely liable for all personal and/or property damage caused by an operator of their vehicle as a result of an accident or incident

### **Terms and Conditions**

- a. Vehicle owner will carry insurance for this vehicle and provide proof of insurance upon registration.
- b. Vehicle Owner shall indemnify and hold harmless Miami Beach Association (MBA) and its members from and against all claims, damages, losses and expenses (legal or otherwise) caused in whole or in part by the Vehicle Owner and / or its operator(s)
- c. Vehicle Owner and its operator(s) will be responsible for the safety of all passengers and any damages or injuries without recourse to MBA (refer to item a. above)
- d. Vehicle Owner and its operator(s) accept all risks while on MBA property including but not limited to theft of Vehicle and / or contents, acts of violence, and natural incidents (acts of God)

**Anyone operating an uninsured or unregistered motor vehicle on MBA roads  
or property will be fined \$50.00 per incident.**

**IMPORTANT: THE PERMIT PLATE MUST BE SECURELY MOUNTED ON THE REAR OF YOUR MOPED, SCOOTER OR GOLF CART**
